NOTICE FROM THE ITF UMPIRE COMMITTEE

The ITF Umpire Committee requires all NGBs of ITF to submit the candidates who are willing to be officiating as Umpires at the next World Championships to be held in Sofia, Bulgaria in 2013 to the Umpire Committee by 30^{th} December 2012. After this deadline, no candidate can be accepted.

The ITF Umpire Committee is going to select Umpires among the Candidates provided by NGBs and they must even attend the Technical & Umpire Seminar to be held in Sofia 2013 before the TWC. Otherwise they are not eligible to be umpiring at the coming World Championship.
